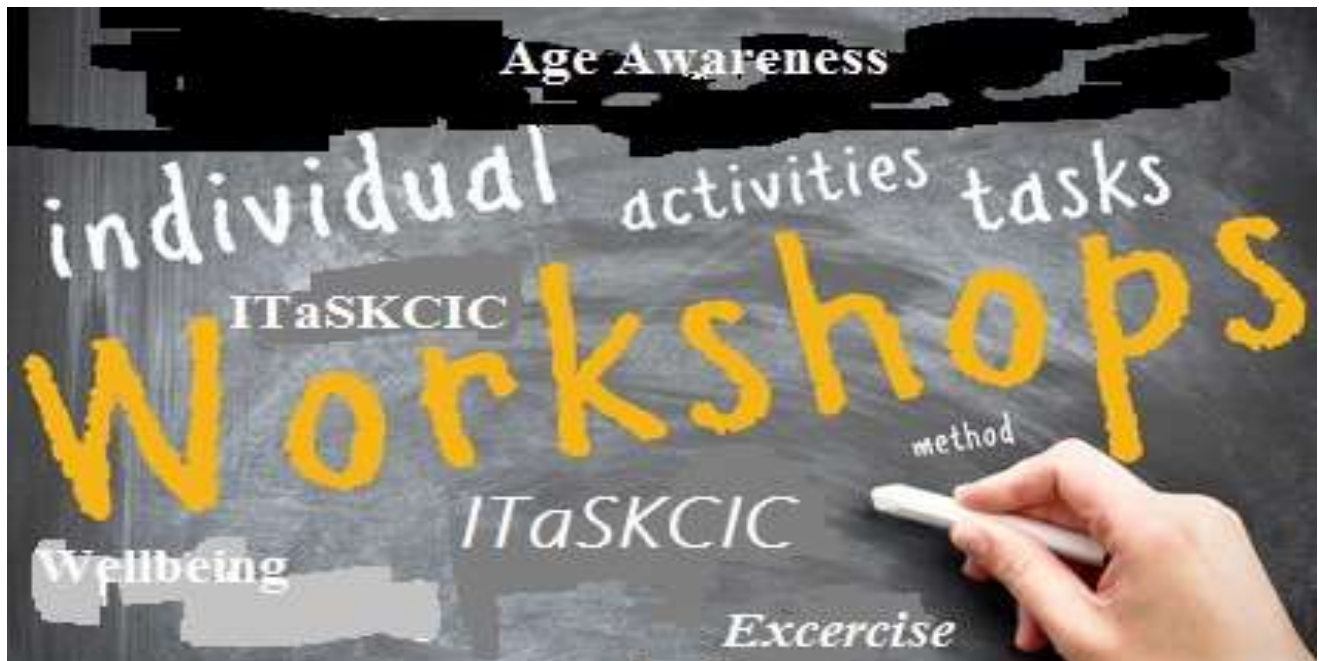

## Courses and Workshops 2017

### Health & Safety Training with ITaSKCIC.

All courses are provided with training content handouts and relevant certificates.

**Asbestos Awareness Course** - Asbestos Awareness Training is designed to ensure workers who may disturb asbestos through their work activity understand the risks associated with asbestos materials. We will help employers to comply with the law by ensuring that their workers are appropriately trained in order to work safely.

**AFTORS - Awareness Training For Occupational Road Safety 2016** - UK law requires employers to treat occupational driving the same as any other health and safety risk. They must conduct suitable risk assessments and take all reasonably practicable measures to manage the risks. The AFTORS course is designed to help employers understand and manage the risks where occupational driving is involved. It also provides advice and resources for drivers regarding road safety awareness.

**CDM Construction Design Management Regulations 2015** - CDM Training Courses: Training courses in this category are related to the CDM Regulations. Course delivery is throughout the UK, either as open courses or as dedicated courses on customers' own sites. Planning is essential from the outset to ensure working conditions are safe and fit for purpose, ensuring that the tasks proposed will not put others at risk.

**Contact Dermatitis and Work** - Contact Dermatitis is a serious occupational skin disease, and many substances used at work are irritants or allergenic. This Workshop also includes information on latex dermatitis and an introduction to the problems of contact dermatitis and its solutions.

**CoSHH Level 1. Awareness Course** - The COSHH Awareness course is aimed at people who deal with hazardous substances on a day to day basis. Delegates will be briefed on the summary of HS&W regulations, the importance of following policies and procedures, safe handling and risk assessment of hazardous substances within their organisation. Completion of the course will give delegates a sound understanding of their personal and legal responsibilities for the control of chemical and hazardous substances.

**Display Screen Equipment and Assessments** - To identify the hazards and risks associated with Display Screen Equipment. Delegates will have practical advice on working safely with DSE equipment and gain a basic understanding of the DSE Regulations 1992 as amended.

**Fire Awareness Training** - For delegates to know how to reduce fire risks, deal with fires if appropriate and escape safely in the event of fire. This course is designed to give you the knowledge and confidence to act safely in the event of a fire, and to aid fire prevention at work. Complies with the Regulatory Reform (Fire Safety) Order 2006. A very stimulating and informative course

**Fire Warden/Marshal Course** - All employers are required to carry out an assessment of the risk of fire in their workplace. As part of their fire plan, an employer may appoint fire marshals, otherwise known as fire wardens, to carry out certain tasks. This will include routine inspections such as ensuring fire exits are kept clear and that fire-fighting appliances are in the right place and alarms are tested.

**First Aid Emergency at Work** - The First Aid Emergency at Work training course enables people designated as a First Aider to carry out appropriate first aid in an emergency situation at work. At the end of the course the candidate will be able to: manage a casualty who is injured at work, or suffers from a serious illness, while waiting for more qualified medical help to arrive. Candidates will also have knowledge of the legal requirement of First Aid at Work.

**First Aid Emergency at Work Refresher Course - Annual refresher courses.** This course does not replace the statutory Emergency First Aid at Work course, it is a refresher for qualified first-aiders to maintain their basic skills and keep up to date with any changes to first aid procedures.

**Food Hygiene and Safety Level 2** - Overall aim is to develop a level of understanding of the basic principles of food hygiene and safety in the catering industry. Complies with the formal training requirement showing compliance with legislation and covers major aspects of food hygiene: Includes an introduction to the New Allergen Laws.

**Food Allergen Awareness** – This course explains the skills required and the understanding of allergens in catering to facilitate compliance with the Food Information for Consumers Regulations 2014. We ensure people are trained on how to prepare food for customers asking for food free of certain ingredients, that they understand the risks of allergen cross contamination and can explain to customers.

**Food Safety, Hazard Analysis and Critical Control Point Seven Principles Training** – This course will develop your skills to comply with the HACCP principles at every stage of the food production (from purchasing, receiving, transportation, storage, preparation, handling, cooking to serving) and will show you how to develop policies for monitoring scrupulously Cost £60.00 per delegate (for block bookings of 6 to 12 £350.00).

**Health and Safety at Work Level 1** – This course has been developed to ensure that delegates are equipped with a basic knowledge of health and safety at work, including the duties under UK health and safety legislation. - Perform correct manual handling techniques for lifting and moving loads

**Noise Awareness Training** – A comprehensive course that provides participants an overview of The Control of Noise at Work Regulations 2005. The Course focuses on key facts and will give delegates an understanding of the issues relating to the measurement and control of noise in their workplace. Cost £60.00 per delegate (for block bookings of 6 to 12 £350.00).

**ITaSKCIC Portable Appliance Testing - PAT testing** – ensuring safety is delivered via our expert engineers who will ensure safety for portable appliances - PAT testing includes report and certification. **Reporting of Injuries, Diseases and Dangerous Occurrences RIDDOR** - This health and safety training course explains: the requirements of RIDDOR, which applies to all work activities in the UK, including the offshore oil and gas industry. The course includes the amendments to RIDDOR which became law on 1st October 2013. BSI. Approved

**Risk Assessor Training - Risk Assessment Course** - Employers and the self- employed have a legal duty to assess health and safety risks. Become a competent assessor, with this workshop you can gain the knowledge and skills to enable you as a competent person to carry out risk assessments.
